## COVID TESTING, THE FIRST INDICATOR

Sounty using federal CARES Act CRF funds, JTCHS is doing all that we can to administer COVID-19 TESTING to help keep the community safe. "The Jessie Trice Community Health System is committed to making the vaccine available to everyone, regardless of income or ethnicity," says Dr. Joycelyn Lawrence, Chief Medical Officer. One of the only testing locations at the time, JTCHS has consistently conducted COVID-19 testing since March of 2020. We met the needs of the community by providing testing during the week and on weekends as necessary. We are continuing to test Monday-Friday at our health center at 5361 NW 22nd Avenue and on select days in Miami Gardens. We are also continuing with outreach partnerships across Miami-Dade County throughout the week.

## **Curbing Transmission**

JTCHS has been able to consistently vaccinate the community since January 2021. We were able to sustain operations by not closing our doors or laying off staff because although we are considered essential, we felt that servicing our community was essential. "We are doing our part to ensure that the most vulnerable populations, particularly minorities, are reached and are able to receive the vaccine. It's the first step towards stopping the spread of the virus and putting an end to this pandemic" says Irene Taylor-Wooten, JTCHS Board Chair. Until August 2021, JTCHS provided all 3 vaccines. Because of the cease in distribution of the Jansen/J&J, JTCHS only provides the Pfizer and Moderna vaccines. Those looking to get vaccinated or receive health care from JTCHS can rest assured that we have adjusted to the new norm and implemented new guidelines to keep patients and visitors safe. The following standards have been put in place:

- No visitors are allowed with adult visits unless providing physical assistance.
- Pediatric patients may be accompanied by **one** adult.
- All guests must wear a face covering or face mask.
- Screenings will be conducted that will include questions about possible exposure to COVID-19, any current symptoms and will include a temperature reading.
- Patients scheduled for a procedure may be tested in advance by JTCHS prior to the procedure.
- Patients that are uncomfortable with coming onsite to see their provider may ask for a virtual visit.
- Facility changes have been implemented to help maintain social distancing. These changes include spacing of chairs to avoid crowded waiting rooms and requesting that patients wait in their vehicle to be called in when the provider is ready to see them.

## **ITCHS Has New Patient Guidelines**

o ensure everyone's safety and well-being, JTCHS has implemented new patient guidelines Among the key new guidelines are the following:

- No visitors allowed with adult visits unless providing physical assistance. We welcome your loved one(s) to participate virtually via your smartphone or tablet. JTCHS staff can help you make that connection.
- Pediatric patients may be accompanied by one adult.
- All guests must wear a face covering or face mask. Please remember to make sure it covers your nose and mouth at all times, and do not remove it unless asked to do so by your provider. Please note that children under two years of age do not need to wear a mask.
- Screenings will be conducted that will include questions about your potential exposure to COVID-19, any current symptoms, and will include a temperature reading.
- If you are scheduled for a procedure, you may be tested in advance by us prior to the procedure. For your convenience, we will provide COVID-19 testing at multiple sites. Call (305) 694-6268 to schedule an appointment.
- If you are uncomfortable with coming onsite to see your provider, you may ask for a virtual visit. Please note the instructions for this posted on our website at **www.jtchs.org**.
- You may notice your provider without a tie, suit jacket, dress, or lab coat. That's because we are wearing clothes that can be washed daily as we return home to our families.
- You will notice changes in our facilities that have been implemented to help maintain social distancing. These changes include spacing of chairs to avoid crowded waiting rooms and you may be asked to wait in your vehicle and be called in when the provider is ready to see you.

All of these aforementioned guidelines have been put in place to help our patients feel safe.

JTCHS knows and specializes in comprehensive health, offering a myriad of services to improve the health of the community. This includes: dentistry, family medicine, nutrition, HIV/AIDS, behavioral health, transportation, healthy start, obstetric & gynecological care, school-based health, community health promotions, health & wellness center, pediatrics, and ancillary services.
